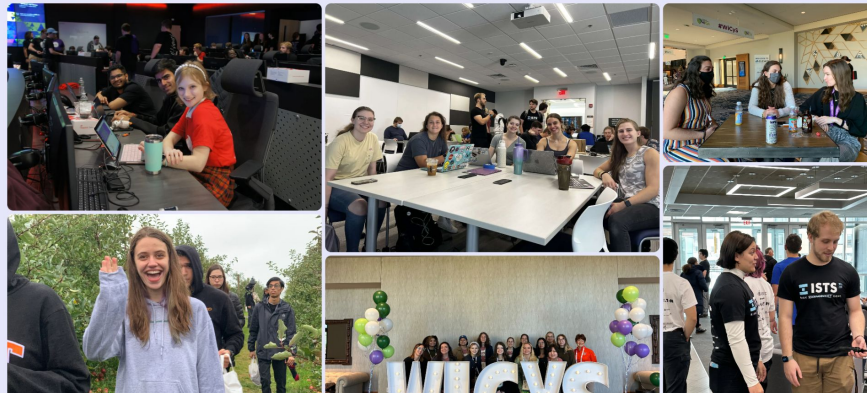

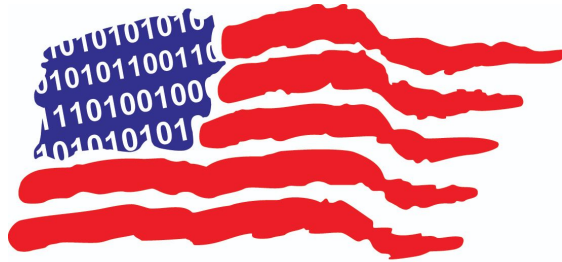

Scholarship Program Eligibility

- Enrolled (or will be enrolled) in **one of three accelerated BS/MS programs**:
 - BS in Computer Science and MS in Computing Security
 - BS in Software Engineering and MS in Computing Security
 - BS in Computing Security and MS in Computing Security
- **US citizenship or legal permanent resident**
- **3.25 overall GPA** or higher
- Completed at least one co-op before beginning the program (can be private sector)
- Must be able to obtain an appropriate security clearance
 - Review the federal SF-86 form but **do not submit it with the application**

Scholarship Program Benefits

- BS/MS
 - Undergraduate Year(s): full tuition and fees, and \$27,000 stipend
 - Graduate Year: full tuition and fees, and \$37,000 stipend
- \$6000 per year for professional development
 - Books
 - Travel to SFS Job Fair
 - Professional certifications
 - Travel to conferences (DEFCON, Shmoocon, SANS Summits, WiCyS, etc)

Scholarship Program Commitments

- Work for approved government agencies after graduation (and internships each summer) for at least the same number of years on scholarship
- **Federal Executive Branch Government Agencies**
- **Other US Governments and their Agencies** (approval required)
 - State, Local, Tribal, or Territorial Government
 - Other Federal Government Agencies
 - Includes Federally Funded Research and Development Centers (FFRDCs)
- **Cybersecurity Faculty Member at an SFS Institution** (approval required)

Position must be related to cybersecurity/information assurance!

Ongoing Scholarship Program Requirements

- Sign CyberCorps® SFS Service Agreement and RIT Forgivable Loan Promissory Notes
- Maintain a **3.25 GPA** or higher
- Accept no outside employment without written permission of the RIT CyberCorps® program
- Continued ability to obtain and/or maintain a security clearance
- Apply for, receive, and participate in internships (co-ops) each summer with an approved governmental agency;
- Apply for, receive, and accept a full-time position with an approved governmental agency upon completion of degrees; and complete service at that agency equal to the time funded by the scholarship

Ongoing Scholarship Program Requirements

- Participate in CyberCorps® cohort activities
 - Outreach (Internal and external)
 - Social events
 - Going to job fairs/events (SFS Job Fair, RIT Career Fair, CAE National Cybersecurity Career Fair)
 - Going to SFS weekly seminar
 - Shadowing faculty research
 - Applying for jobs, resume editing
 - Going to conferences
- You must complete ~60 hours worth of SFS activities a month to earn stipend
 - Not as difficult as it seems!

Application Materials

- Application Form
- Your most current unofficial transcript
- Your current resume
- Two letters of professional reference
 - At least one from an RIT faculty member and one from a co-op or other job supervisor
- One letter of personal reference
 - Can be from a family member
- Personal statement (similar to a cover letter)
 - Motivations for wanting the scholarship, wanting to work for government, etc.
- Draft Worksheet for your BS/MS program (get this from your advisor)

- Interviews: **April 2024**
- Admission decisions: **Late May 2024**

Understanding Public vs. Private

- Economies separated into sectors representing different aspects of economic activity
- Public: Government agencies that provide services to the public
- Private: represents businesses of ranging sizes with the goal of generating profit



Private Sector

- Funded by revenue and can range in size
- Variety of different businesses
 - Hospitality, technology, legal, etc.
- Businesses provide similar goods and services and will compete with one another



Public Sector

- Comprised of government agencies at 3 levels
 - Federal; State; Municipal
- Funded by tax dollars and not revenue driven
- Same type of jobs as private sector



Employment

- Private:
 - Have more flexibility
 - Each employer sets its own rules so long as it follows the OSHA guidelines
- Public:
 - Work under federal service system
 - Job security

Work life balance

- Private:
 - Demand long hours
 - Can offer more flexibility regarding work arrangements
- Public:
 - Provide more stability
 - Regular work hours
 - Less overtime

Impact of Work

- Private:
 - Can offer the satisfaction of solving complex problems
 - Innovation and driving economic growth
- Public:
 - Work on policies and programs that directly serve the community
 - Can provide strong sense of purpose

Cultural Differences

- Private:
 - Can be more dynamic and change oriented
 - Considered more productive and competitive
- Public:
 - More formal in some branches
 - Hierarchical structure
 - Slow to change
